III Regional Congress on Women in the Context of Migration

"Women In Movement: Gender Equality, Human Rights and Autonomy"

with the support of IOM and the Grand Duchy of Luxembourg

Mexico

23 and 24 September 2021

BACKGROUND

Member Countries of the Regional Conference on Migration (RCM) have recognized the relevance and increasing engagement, and new patterns of women, associated to the feminization of migration. It is for this reason that the realities of migrant women have a very significant impact in the region, requiring an effective approach from a regional and domestic perspective in RCM Member Countries.

Since 2017, under the leadership of El Salvador as the Presidency Pro-Tempore of the RCM, a reflection on "migrant women" was advanced. The effort to position this at the regional level was due to the dynamic characteristics of migration in the region, while simultaneously seeking to position the RCM as a regional reference process for the protection and attention of migrant women throughout the different stages of the migration process.

The I Regional Congress: Women in the context of Migration, was held in 2018 in El Salvador and had the objective of opening a space to broaden the knowledge on the intrinsic link between women, migration and development; and under this context the *Guidelines for the Attention and Protection of Women in the Context of Migration*¹ were presented.

The II Regional Congress: Women in the Context of Migration: "Women in Migration: Gender, Human Rights and Empowerment. Challenges and Perspectives", was held in 2019 in Costa Rica. This Congress followed up on the application of the *Guidelines for the Attention and Protection of Women in the Context of Migration*. Working groups, panels and discussion sessions were established to address Women and Work, Gender-based Data, Migrant Children and Adolescents, Role and Prominence of Women in the 2030 Agenda, Women and the Global Compact for a Safe, Orderly and Regular Migration, Violence Against Women and Public Policies, Migrant Trafficking and Smuggling, among others.

In addition to such efforts, and at the request of Member Countries to turn the Regional Congress into an annual space of reflection, the III Regional Congress on Women in the Context of Migration: "Women in Movement: Gender Equality, Human Rights and Autonomy" will be held.

JUSTIFICATION

According to information from the International Organization for Migrations (IOM), an estimated 281 million people have crossed international borders globally; for this particular region this represents 52% girls, adolescents and women.² Women and girls leave their place of origin seeking new alternatives for survival due to the pressures inflicted by organized crime, poverty, lack of opportunities, environmental deterioration, natural disasters, persecution and job insecurity, among other factors. Also, an important number of women and girls flee their place of origin due to structural cultural factors that spur expressions of violence against the most vulnerable segments of society, such as gender-based violence, homicide, family abuse, trafficking, forced marriage; or several forms of discrimination, including those related to sexual orientation or gender identity.

Based on this, the III Regional Congress will highlight the importance of recognizing that:

a) Migrant women provide critical social and financial contributions to countries of origin, transit and destination. In certain cases, migration offers opportunities for economic and social development. The experiences from migration - when positive- help to empower women and girls by boosting their self-confidence, autonomy and control of their own lives; and the exposure to different gender norms can contribute in attaining gender equality in the communities of origin.³

Migrant women can maintain a greater level of autonomy, and benefit from the new norms, competences and specialized skills that are taken when returning and reintegrating back into their communities of origin. The acquisition of assets when returning, also improves their developing situation. A high percentage of women that return to their country of origin, start their own business while others become independent workers, this suggests a higher financial capital. Migration enables women to become agents of change and of development, including their families and communities. The predominant role that women play in reactivating a post-COVID19 pandemic economy is reaffirmed, and therefore, it is critical to establish adequate conditions to ensure this occurs.

b) This pandemic has caused many women to abandon their work activities in order to respond to the demands of home care, which rearranges the chains of home care and support that were provided by other female family members, thus, increasing their vulnerability. It is crucial to highlight the importance of having access to security, protection and basic social services, particularly access to health, and the challenges that this implies to Member Countries in providing such services to women and girls in a context of mobility.

c) Migrant women may be disproportionately affected by intersectional discrimination that occurs when several categories of exclusion converge, as well as from the design of programs that lack a gender focus.

According to the Guidelines for the Attention and Protection of Women in the Context of Migration, "intersectionality is a tool for analysis, advocacy and policy making that addresses multiple types of discrimination and helps us to understand how different identities influence the access to rights and opportunities". Another critical tool when analyzing the approach of several adverse and structural factors of migration is precisely a focus on gender. Its incorporation allows questioning traditional roles and the responsibilities that are associated to gender, creating a process that reassesses the implications of the actions of public policies on men and women.

In this particular context, it is crucial to continue advancing the agenda on Gender Equality and Human Rights of women and girls, as well as continuing with the contribution and commitments from prior Congresses. Particularly, following up on the implementation of the *Guidelines for the Attention and Protection of Women in the Context of Migration* by Member States, strengthening gender mainstreaming in public policies aimed at migrants, and channeled through RCM's leadership, as well as encouraging Member States to intensify the institutionality of gender-based migration policies.

OBJECTIVES

General Objective

To advance the exchange of experiences and best practices, disseminating knowledge and generating a dialogue aimed at delivering proposals for the attention of women and girls in conditions of mobility, and developing their autonomy and empowerment from a perspective on gender, intersectionality, human rights and inclusion.

Specific Objectives

- To generate a dialogue that allows broadening the knowledge regarding the situation of
 migrant women and girls in the region, particularly in the context of this pandemic;
 sharing best practices and experiences regarding the measures taken by countries in
 order to protect their rights, as well as developing their autonomy.
- To transcend the dominant vision of assistance towards migrant women and girls and begin referring their importance in terms of real (re)integration and substantial equality in the different spheres of life, and not just in the productive fabric, by recognizing their capacity as agents and diverse contributions in the countries of origin, transit, destination and return.









 To encourage an exchange between Member Countries in identifying areas of opportunities in order to strengthen gender-based public policies aimed at migrants, according to the application of the Guidelines for the Attention and Protection of Women in the Context of Migration by each of the Member States and recommendations issued by the working groups.

METHODOLOGY

The III Congress will be held in a bimodal format (face-to-face and virtual) on September 23rd and 24th 2021; it will be organized by the RCM Presidency Pro-Témpore, the National Institute for Women (INMUJERES) and the National Institute for Migration (INM) on behalf of the Government of Mexico, in coordination and with the technical and financial support of the IOM and the Grand Duchy of Luxembourg.

The methodology will be centered on continuous exchange, engagement and collective building, so several activities will be developed:

- Panel of Experts. Specialists from Member Countries and Organizations that will focus on specific themes, encouraging exchange, dialogue and learning.
- Thematic Roundtables. Their intention is to provide a platform for the horizontal exchange and collective reflection between representatives of countries, international bodies and organizations from civil society. Two work roundtables will be held daily.
- **Closing Plenary.** This space will showcase the outcomes obtained by each thematic roundtable and will facilitate establishing agreements on a line of action.
- Rapporteurs. Two people will assist in drafting a report regarding the development of the Congress and will help identify the advances made by the themes in the region and areas of opportunity.
- Artistic and Cultural Activities. Different activities will be developed to help strengthen a
 positive image, free from stereotypes and discrimination; including a Photograph Contest
 on Women and Girls in Mobility "Women in the context of migration, Eliminating
 Discrimination" that will showcase all photographs received, and present contest winners,
 and the overall winner of the contest. Also, the activities will be presented in such a way
 that they promote the integration of migrant women in the country of destination or return;
 narratives and testimonies that reflect the contributions made by women in mobility, as well
 as guided tour of Los Pinos Cultural Complex, the main venue of the Congress.











PARTICIPANT'S PROFILE

At least two participants from each Member Country are expected to attend, with the following profile:

- National Mechanisms for the Advancement of Women (Ministries, Directorates and National Institutes for Women) and/or,
- Institutes/ Directorates of Migration and other agencies related to migration, and/or,
- Ministries of Foreign Affairs, areas related to the subject matter.

A varied participation of organizations from civil society is also expected; particularly the Regional Network for Civil Organizations on Migration (RNCOM) and RCM Observer Organizations, national and international subject matter experts, and migrant women who will share their personal experience and/or success story.

THEMATIC AGENDA

The Congress will address the following central thematic axis:

- Economic empowerment of migrant, refugee and returned women under an intersectional perspective.
- Challenges to ensure Human Rights of women and girls in the context of mobility in times of the COVID-19 Pandemic.
- Equality and non-discrimination towards migrant women and girls. Stereotypes and intersectional discrimination
- Review of the progress made with regards to the *Guidelines for the Attention and Protection of Women in the Context of Migration*, as well as follow-ups and monitoring.
