Intersectoral consultations have been carried out between government, civil society and international organizations.

The Information System and operational monitoring of cases of migrant smuggling and trafficking in persons (SISOTT)

Created with the technical assistance of the ACP-EU Action on Migration, the financing of the European Union (EU) and the development and implementation of the International Organization for Migration (IOM).

Initially, created as a pilot for the Specialized Attorney in the interest of improving the management of investigations of these crimes and facilitate the production of information for decision making and accountability at national and international level.







Operational Guidelines for the Investigation of Illicit Trafficking in Migrants and Trafficking in Persons

Prepared with the technical assistance of the ACP-EU Action on Migration, the financing of the European Union (EU) and the development and implementation of the International Organization for Migration (IOM).

The objective is to allow the Public Prosecutor and investigators to effectively carry out investigations into cases related to these crimes.

Workshop to strengthen human and institutional capacities in the investigation of crimes linked to irregular migration, 22-24 November 2017, Santo Domingo.

Aimed at judges, prosecutors and investigators, to expand their knowledge and skills in the procurement of justice on the typical behaviors of trafficking in persons and migrant smuggling crimes, the applicable international provisions, including international cooperation and assistance, as well as the effective identification, investigation and prosecution of these crimes.

Taught by the Organization of American States, OAS, within the framework of the "Prevention of crimes linked to irregular migration in Mesoamerica" program.

PROGRESS REGARDING **ASSISTANCE AND PROTECTION** TO VICTIMS



Signature of Memorandum of Understanding between the Social Policy Coordination Cabinet, the Ministry of Foreign Affairs, the Attorney General's Office and the National Institute of Migration, dated June 23, 2017.

The objective is to combine technical, administrative and financial efforts among the signatory entities, in order to establish technical cooperation actions for the creation of a *Pilot Program for the Protection and Reintegration of Dominicans deported and returned, including the victims of trafficking and trafficking. of people.*







Residence Visa to trafficking in persons victim

In 2014, as a protection measure, the migratory regularization was approved with a work visa to a Chinese national, survivor of labor exploitation, renewed annually.

In 2017, a residence visa has been approved to grant the resident's immigration status, in continuity with the measure of protection and guarantee of their human rights as a survivor of trafficking.

Specialized home for adults victims of human trafficking

It was opened in May 2016, for temporary use, in which national and foreign victims were assisted.

Currently, it is in the process of signing a collaboration agreement to cede the administration of the Home for permanent use, in charge of the Catholic Congregation of the Oblate Sisters of the Most Holy Redeemer.
