## Report on the work carried out between the RCM and SACM Troikas regarding the Global Compact and coordination mechanisms between the two consultation processes

I Virtual Meeting of Troikas CRM-SACM

• It was agreed to work together to cover the contents of the Global Compact for safe, orderly and regular migration. The next meeting in Washington is called before the CAM meeting.

Meeting of the Member Countries of the RCM in Washington D.C.

- Background document of what the RCM has had in relation to the issues raised in the GCM.
- Document of good practices throughout the 20 years of the RCM that served as an input to the GCM.
- Proposed political declaration that serves as a flag document in relation to the GCM.

Meeting of Troikas RCM-SACM in Washington D.C. Create an ad-hoc working group to advance in the elaboration of an input proposal, agreed between both processes, that serve for the elaboration of the Global Compact for a safe, orderly and regular migration. Virtual meeting of the Member Countries of the RCM

• Disseminate among the Member Countries of the RCM the draft Joint Declaration of the United States, Canada and Mexico.

Virtual meeting between Troikas from the RCM and SACM • The celebration of an annual meeting of Troikas was defined, in order to assure the continuous work between both regions. In addition, it was agreed to work in coordination with the Ad-Hoc Group, in the construction of an information portal and take advantage of concerted meetings to meet between SACM and RCM.

Virtual meeting of the Member Countries of the RCM

 It was entrusted to the TS to provide a document with regional guidelines regarding the impact of agreements. Work meeting between the RCM and the SACM in Panama

- Propose jointly between RCM and SACM lists of experts who can represent Latin America as speakers in the thematic consultations.
- Initiate a consultation process within each Conference, with a view to having each Conference and each Member Country of each Conference arrive with agreed inputs to be considered in the framework of a RCM-SACM plenary consultation.
- Advance in a process of elaboration of definitions for some essential concepts for the region, based on the questionnaire that has been worked in the framework of the RCM.

Working meeting between the RCM and the SACM to build bi-regional inputs related to the Global Compact for safe, orderly and regular migration (GCM) and follow-up on work on extra-regional migrants Berlín, June 29, 2017

#### Participation:

**RCM:** El Salvador, Honduras, México and the Technical Secretariat of the RCM

**SACM:** Paraguay, Uruguay and Chile.

Topics related to the exchange of information, preparation of bi-regional inputs, coordination to strengthen bi-regional positioning before the GCM and joint work related to extra-regional migrants were covered.
